Your National Unions are Fighting for YOU

Our national affiliates are the American Association of University Professors (AAUP), American Federation of Teachers (AFT), and American Federation of Labor & Congress of Industrial Organizations (AFL-CIO). Following is an *incomplete list* of how they are *fighting to protect your funding, your academic freedom, and your constitutional rights to free speech* during this time of attacks on higher education in the U.S.


- AAUP is one of several plaintiffs in a court case fighting Executive Orders intended to freeze federal grants and contracts. That lawsuit has so far resulted in a restraining order on termination of grants and contracts.
- AAUP is again one of several plaintiffs in a <u>lawsuit against Executive Orders to</u> <u>cease DEI work</u>.
- AFT is a plaintiff in a <u>new lawsuit</u> against the U.S. Department of Education's 2/14/2025 "<u>Dear Colleague</u>" letter.
- AFL-CIO and AFT are two of several union plaintiffs in <u>lawsuit against DOGE</u> to protect privacy of worker data.

Requests from AAUP:

- Report impacts to your grant or contract funding resulting from recent Executive Orders
 - send a short summary of your situation to <u>anisenson@aaup.org</u>, senior counsel for AAUP.
- Fill out this <u>DOGE impacts on higher ed</u> Google Form if your work has been affected by recent actions or policies of DOGE.
- Fill out and/or share this <u>survey on impacts of deportation EO</u> if deportations are occurring at your workplace or in your area.

Other Items from our National Affiliates and Sibling UA Unions:

- Review AAUP's <u>page of resources</u> to help resist political attacks on higher education.
- Add your name and story (if applicable) to thisopen letter to Senator Murkowski and Senator Sullivan, in response to threats to federal funding. This letter was begun by UA's graduate student worker union, AGWA/UAW, but all affected UA community members are encouraged to sign.



The UA Board of Regents Motion on DEI

If you have not yet read the motion passed by the Board of Regents on Friday, February 21, 2025, please read the full text of the motion here. Note that Regent Purdue was absent. Regent Selimi, the student regent, voted against this motion. All other regents voted in favor. If you haven't signed yet, please sign our petition, "Standing up for Diversity, Equity, Inclusion, and Academic Freedom."



Use Your Faculty Time Off or Cash-In up to Five Days

To use your Faculty Time Off (FTO), claim it on your timesheet for the appropriate dates.

To cash in your FTO in lieu of taking time off, fill out the FTO Cash-In form.

Workloads

Work with your colleagues and department chair to determine your FY26 workload. For those of you not at extended sites, workloads are due to your department chairs by March 1, 2025. Faculty at extended sites should send workloads to your director or supervisor by April 1, 2025. Department chairs should send all workloads for your department to your dean or supervisor by April 1, 2025.

Deans, directors, and other supervisors have a right to make changes to your workload but are required to attempt a meeting with you to discuss the changes.

Please contact your union leadership if you have questions about your workload or the workload process.

UAF Organizational Vice President Update

The nomination period has now closed. We have two candidates for the UAF Org VP position: Art Nash (cooperative extension) and Ingrid Johnson (justice department). UAF members in good standing received an email announcement with details about the candidates on Thursday, February 27, 2025.

The election will begin Monday, March 3, 2025, through Thursday, March 13, 2025, for UAF members in good standing. The election will then be certified by UNAC's election committee and announced no later than Monday, March 17, 2025. Thank you to Ingrid and Art for running in this important election!

Ratification and Constitutional Changes: Election Results

Voting for CBA ratification and adding a new standing committee to our constitution closed at 11:59 pm on Sunday, February 23, 2025. Your UNAC Election Committee certified the results, and Election Runner's fraud detector found zero instances of fraud or attempted fraud. Following is the outcome of the election.

Collective Bargaining Agreement (CBA) Ratification

Our TA'd CBA was ratified by our members-in-good-standing, with 87% of votes in favor of the new CBA and 13% opposed to it. It's important to note that only 42% of eligible voters cast their votes. Thank you to those of you who voted in this important election! The ratified CBA was approved by the BOR on Friday, February 21, 2025, pending ratification by our membership. Next, the CBA will be sent to the Alaska Department of Administration for approval, and then an adjusted budget will be sent by UA management to the Alaska legislature.

Adding Committee on Non Tenure Track Members to our UNAC Constitution

Our newest standing committee was approved, with 92% voting to add the Committee on Non Tenure Track Members to our Constitution's list of standing committees.

Strike Solidarity Corner

- Thousands of University of California healthcare, research and technical employees spread over 10 campuses began a 3-day strike on Wednesday, February 26, 2025 (more here)
- Statewide strike by New York Correctional Officers; NY Governor says strike was a 'wildcat strike' (did not follow legal statutes) but a deal has been reached. (more here)
- Nurses and doctors at 8 Providence Hospital and Clinic sites in Oregon ended a six-week strike with major gains in compensation and improvements to staffing ratios. (more here)

 Nearly 2,000 University of Oregon faculty have pledged to go on strike on March 16 if no reasonable gains are made in negotiations, which have been ongoing for over a year. (more here)
