Check Your Paystubs for Health Plan Arrears

All returning health plan participants should review the special announcement we sent on September 11, 2025, regarding erroneous health plan arrears deductions. It's in your best interest to review our announcement and then review your deductions if you haven't already. Contact us at contract@unac4996ak.com

One obvious solution for management to avoid arbitration and settle this mess is to offer employees with partial or no summer contract extensions *the option to be paid evenly over 12 months*. HR has indicated the in-progress Banner upgrade may make this possible. Meanwhile, the arbitration is set to take place in mid-October.

UNAC Professional Development Funds Are Open

As departmental Fund 1 travel budgets become ever more elusive, our UNAC Professional Development Funds have become a primary resource for UNAC's

bargaining unit members. Back in 2016, our Negotiation Team won the inclusion of these professional development funds in our CBA (article 15.9).

Our CBA is the reason you continue to have access to these funds. All bargaining unit members of every job title are eligible for these funds. Each MAU's Provost Office manages the application process; contact them or your Org-VP for specific assistance.

UA Travel Paperwork Requirements



UA now requires that you submit travel paperwork in advance anytime that you are traveling for work - even if the university is not contributing to the cost of the travel. Also be aware that anytime you are traveling out of the U.S. with your work computer or other work equipment, even if you have taken time off or are funding your own travel, you need to complete additional paperwork. Failure to do so has resulted in disciplinary actions against some of our members. Save yourself the headache and fill out the paperwork before travel if you are taking UA equipment with you, even if your travel is not UA funded. Visit this UA Travel website for more information.

Academic Freedom in 2025

A video circulated earlier this fall showing a Texas A&M instructor being secretly recorded by a student who challenged the day's topic of discussion, ultimately taking the video to the school's president and getting the instructor fired and the dean and department chair demoted. The president stepped down shortly after (more here). These are scary times.

One difference to keep in mind between Texas A&M and the UA system is their faculty don't have a union or a CBA. Texas doesn't allow collective bargaining; Alaska is a strong union state. Article 6 of our CBA protects academic freedom, guaranteeing every bargaining unit members' right to teach, research, and create according to the norms and latest innovations or discoveries in the discipline without fear of retaliation or job loss. This protection is more valuable today than in recent history.

It appears that the BOR's February actions to eliminate DEI language and personnel did not save UA from losing millions of federal dollars overnight


after the Federal Department of Education cancelled already approved grants for Alaska Native and Native Hawaiian Serving Institutions.

This funding directly employed some of our members and UA staff and supported hundreds of students to foster success among Alaska Native students, buoying all student experiences in the process. They voted to appropriate the money and now it's been cut, to the detriment of Alaskans and the UA system.

Kill the Cuts to Protect Federal Funding

The Federal funding threats are coming from every direction this fall. In anticipation of Congress's upcoming votes on spending budgets, UNAC is co-hosting a Kill the Cuts Town Hall with the graduate student union, AGWA/UAW, and the new staff organization, CAUSE/UAW. Higher Education in the News

- 14 Alaska State Legislators signed and sent a letter to our D.C. delegation, emphasizing the importance of maintaining federal funding at current levels. UNAC facilitated the writing of this letter. (more here)
- A UNAC faculty member & P.I. at UAF is still waiting for \$7.5M in federal grant funding for a critical mineral mapping project to be unfrozen by the Department of Energy. (more here)
- UC faculty, staff, and students, supported by local unions, AAUP, and other non-profits, sued the Trump administration over threats to academic freedomthe right to teach and learn. (more here)
- UC Berkeley sent 160 names to the Trump administration over allegations of antisemitism, infringing on academic freedom and campus free speech. (more here)
- Columbia's professors begin putting academic freedom statements in the syllabi. (more here)

Strike Solidarity Corner

Unionized workers from varied occupations have been going on strike against their employers. Their occupations vary, but one thing remains the same. They are all demanding respect in the form of higher pay, better benefits, and improved working conditions.

- University of Minnesota (UM) custodial staff won a new contract with UM after Farm Aid musicians, including Willie Nelson, refused to cross the picket line to perform on campus. (more here)
- Instructors at Kenya's public universities went on strike to demand backpay to 2021 and implementation of their 2021 CBA. Things might seem bad in the US, but at least our CBA is implemented, and raises are in place! (more here)


UNAC Sick Leave Bank
